

# **PRIVACY POLICY**

Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the site.

Ascend Business Consulting respects your right to privacy. We are committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth).

Ascend Business Consulting does not operate outside of Australia, therefore even though our Privacy Policy may comply with other privacy legislation such as GDPR, it is incidental. If you are outside of Australia, please make your own assessments about your privacy in accessing our website.

This policy sets out how we collect and treat your personal information. "Personal information" is information we hold which is identifiable as being about you.

### **Collection of personal information**

Ascend Business Consulting will, from time to time, receive and store personal information you enter onto our website, provided to us directly or given to us in other forms.

Information that we collect may from time to time be stored, processed in or transferred between parties located in countries outside of Australia. These may include, but are not limited to New Zealand, USA.

If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.

Where we disclose your personal information to third parties, we will request that the third party follow this Policy regarding handling your personal information.
